

Saskatchewan Music Festival Association (SMFA) Car Raffle Rules

- Raffle tickets will not be sold to a person under the age of 19 years. Raffle ticket sellers will be required to tell the ticket buyers not to write the name of a person under the age of 19 years on the ticket due to Public Trustee Act requirements. Tickets cannot be sold to a third party.
- Only 3,000 single tickets are available at \$20 each. The official ticket is a receipt of purchase. It is the responsibility of the ticket purchaser to ensure that they receive their ticket(s); however, purchasers do not need their ticket(s) in hand in order to be included in respective draw(s). No refunds will be issued. Ticket purchases are not tax deductible.
- Ticket distribution and draw control by: Saskatchewan Music Festival Association (SMFA). The records of SMFA shall be deemed correct and final.
- The draw, for all ticket purchasers, will be held **August 10, 2019 @ 9:30 p.m.** in the Convocation Hall (Peter MacKinnon Building) University of Saskatchewan (107 Administration Place, Saskatoon SK, S7N 5A2). The deadline for final draw ticket purchases will be **August 9, 2019 at Midnight.**
- There are no restrictions on the licensee staff and board members and family purchasing tickets
- Once a ticket has been purchased, refunds will not be granted. The only exception would be in the unlikely event the raffle is cancelled. At that point, SLGA rules and guidelines will be followed for proper reimbursement to all ticket buyers.

Prize Claim

- One (1) car valued at \$23,835 (including all taxes and fees) will be awarded. No cash value or exchanges are available to winner. Prize will be awarded to the individual named on the official ticket. If a winning ticket is purchased in the name of more than one person, the prize can be awarded to any name listed on the ticket. The SMFA and the SLGA are not responsible for any disputes which may arise. Prize value stated is retail at the time of tender. The prize must be accepted as awarded. Vehicle is awarded free of any hidden costs. It shall be the responsibility of the winner to license and insure the vehicle from the time of their ownership. The prize, which is not claimed shall be secured for a period of 90 days from the date of the draw. Unclaimed prize will be reported and SMFA will make a request to SLGA to use the prize or the proceeds of its sale to benefit the SMFA which is a non-profit charitable organization. Car must be picked up at the dealership.
- No cash will be offered as an option in lieu prize.
- Winners will be contacted by phone at any available home or work phone numbers. If they cannot be contacted by phone, a letter will be mailed or emailed to the address indicated on the ticket. Names of the winners will also be posted at www.smfa.ca. Prize must be claimed within 90 days. If the prize has not been claimed, within 90 days, the SMFA will make a request to Saskatchewan Liquor and Gaming Authority (SLGA) to use the prize or the proceeds of its sale to benefit the SMFA.
